The application requests that the land use plan map be amended to change the land use designation of Tax Parcel 6-6-46 (12 +/- acres), located at (NE ¹/₄, NW ¹/₄, Sec. 7., Edgerton) from "A-1 Agricultural District" to "Special Purpose Distrct." *A rezoning of the property from A-1 (Agricultural District) to SP (Special Purpose District) has also been requested and will be considered at the public hearing*.

And, an application has been filed by Beatrice Morrison requesting a zoning amendment of Tax Parcel 6-6-50.1 & 6-6-50.2(11.11 acres), located at (6307 W State Road 59, Edgerton) from "A-1 Agricultural District" to "Special Purpose Distrct." *A rezoning of the property from A-1* (*Agricultural District*) to SP (Special Purpose District) has been requested and will be considered at the public hearing. The public may review copies of the application and the Comprehensive Plan at the Town Hall during regular Town Office hours.
