## Notice of Public Hearing Town of Fulton Planning & Zoning Commission

NOTICE IS HEREBY GIVEN that a Public Hearing will be conducted by the Town of Fulton Planning & Zoning Commission on **Tuesday, May 12<sup>th</sup>, 2020**, at **6:00 p.m**. at the Town of Fulton Town Hall, 2738 W Fulton Center Dr., Edgerton, WI 53534 to consider a proposed amendment to the Town of Fulton Comprehensive Plan map: 2035 *and an accompanying rezoning*. The purpose of the public hearing is to accept public comments on the proposed amendment *and rezoning application*.

An application has been filed by Phillip D. Lund (Michael Hodges/Sharon Jensen POA) requesting an amendment to the land use plan map adopted as part of the Town Comprehensive Plan. The application requests that the land use plan map be amended to change the land use designation from Residential to Industrial/Special Use of Tax Parcel 012 01402, and 012 01402.01, Parcels 6-6-55.1 and 6-6-55.1A, the site address being 5940 W Pomeroy Rd., Edgerton, WI. They are proposing this as the parcel adjoining it is Industrial/Special Use, and they are requesting this for outdoor storage of roll off dumpsters. *A rezoning of the property from R-RS (Rural Residential Small) to I-L (Industrial Light) has also been requested and will be considered at the public hearing.*
