#### **ABOUT THE NORTH ROCK SOLAR PROJECT**

The North Rock solar project is an up to 50 MW solar site under development on approximately 450 acres in the Town of Fulton, Wisconsin. The project is currently proposed to interconnect to the electrical grid at the ATC Sheepskin Substation via a proposed 69 kV Transmission Line which will extend north from the



Project Area north towards existing electrical infrastructure. Permitting for the project through the Town of Fulton is anticipated to begin in March 2020, with construction to begin as early as the spring of 2021 with an operational target in 2021.

**Estimated North Rock Local Economic Impacts During First 20 Years of Operations (based on 50 MW project size)**

- Tax Revenue: ~\$5 million (~\$200,000 annually)
- Education Fund: ~\$200,000 (~\$10,000 annually)
- Jobs: 3-5 full-time jobs and 150 construction jobs
- Plus thousands in local infrastructure improvements and local spending
